COMMITMENT ON THE PROTECTION OF IPRs

To: Beijing Textile Machinery International Exhibition Co., Ltd, as the Organiser of ITMA ASIA + CITME 2008, and all the sponsors of ITMA ASIA + CITME 2008.

To protect fully the intellectual property rights (**IPRs**) of all exhibitors during **ITMA ASIA + CITME 2008**, and in accordance with the Chinese Intellectual Property Rights Laws and the regulation “the Measures for the protection of Intellectual Property Rights during Exhibitions”, **(company’s name)**, as an exhibitor of the exhibition, hereby confirms the following:

1. The exhibitor shall not violate any Chinese law, administrative regulation or decree concerning intellectual property rights and any international treaties or pacts concerning intellectual property rights applied in the People’s Republic of China.
2. During the exhibition, the exhibitor shall not show any product which infringes the intellectual property rights of any other party or show any product which is under administrative or judicial procedures due to disputes concerning intellectual property rights.
3. During the preparation period, the exhibitor shall do some legal research and examinations on the exhibition items (including exhibited goods, exhibited boards and relevant publicity materials, etc.) via Chinese official **IPRs**’ databases; during the exhibition, the exhibitor may bring the relevant certificates of **IPRs** which are recognized and which are legitimate in China.
4. The exhibitor shall provide active cooperation for the investigation for obtaining the evidence, inspection and enquiry work conducted by the Chinese **IPRs**’ administrative department or judicial department, and shall also provide cooperation for any other work concerning the protection of **IPRs** conducted by the organiser.
5. Under the request of the Chinese **IPRs**’ administrative department or judicial department, the exhibitor shall remove the exhibited goods, exhibited boards and relevant publicity materials which are suspected of infringing **IPRs** owned by other parties.
6. The exhibitor shall bear all responsibility for any losses or damages suffered by the organiser and all the sponsors of **ITMA ASIA + CITME 2008** as a result of the exhibitor’s infringement of any other party’s **IPRs** or the exhibitor’s false complaint.
